

## Introduction

This Special Report on the Coronavirus (COVID-19) Pandemic published in 2020 by the non-profit National Vaccine Information Center (NVIC) is a collection of referenced news analyses and opinion essays written by NVIC Co-founder and President Barbara Loe Fisher and published in NVIC's weekly journal newspaper *The Vaccine Reaction*.



In chronological order, it summarizes information about major events and articles published in the medical literature and by the media after Chinese government officials announced on Dec. 31, 2019 that 44 patients with

pneumonia of "unknown etiology" (unknown cause) had been identified in Wuhan, China.<sup>1</sup> By Jan. 30, 2020, the World Health Organization (WHO) declared a "Public Health Emergency of International Concern" after confirming that a mutated coronavirus (COVID-19) was circulating in certain regions of China for which human populations reportedly have no natural immunity.<sup>2</sup>

On Jan. 31, 2020, the U.S. government declared a public health emergency.<sup>3</sup> By the end of March 2020, all 50 states had declared a public health emergency that led to orders by most state Governors for citizens to selfquarantine at home and close businesses, schools, restaurants, shops and malls, churches, parks, beaches, gyms, sports arenas and other public spaces for at least four weeks, although some states extended the "lockdown" to up to 10 weeks.<sup>4</sup>
