crime that has no bounds.

For months, I've been writing about the "missing virus" and the studies that should be done to prove it exists—real-world studies that have never been done and will never be done. Now, here is the smoking gun.

I'm aware that many scientists and doctors, who are otherwise exposing the pandemic as a fraud on legitimate grounds, don't want to touch what I'm revealing here. I would remind them that, months ago, when some of us were already exposing the PCR test as unreliable and useless and deceptive, THAT ISSUE was too hot to touch. But now it isn't.

The issue of the existence of the SARS-CoV-2 virus may seem as if it's too hot, but it isn't. It's time to launch a full-on attack. Immediately.

The truth is only bitter for those who are hiding it.

I'm also aware there are people who have been building scenarios about how the virus is "activated." Certain frequencies wake it up, and so on. Well, the question is: WHAT VIRUS? THE ONE THAT ISN'T THERE?

Still other people would say, "Then what are all these scientists sequencing in their labs, if it's not the virus?" Again, not our problem. They might start with a piece of RNA, and then claim, without proof, it's part of SARS-CoV-2; and they go to work on it. They claim anything they want to. It's not

science.

If a mechanic says he has a piece of a fender from a car that has never been seen before; if he claims he knows the car exists; but he can't show you the car; are you going to buy his story? Are you going to invest your life-savings and life-savings of your family and friends in this car he admits is "unavailable?" Are you going to invest and go broke and sit in your home and wear a mask and keep your distance from other people and close your business and declare bankruptcy? Are you going to consent to that?

Another question that arises: if the virus is missing and has never been isolated, has never been proved to exist, what are they putting in the COVID vaccine? That's a question that should be answered by lawenforcement agencies raiding many facilities and seizing materials and finding honest scientists who will discover what is really in the COVID vaccine brews. Waiting for that to happen...the sun could go dark first. In the meantime, do you want to take the shot in the arm?

Some people have claimed there are "animal models" which prove the coronavirus exists and is harmful, because the animals become sick, when they are "injected with the virus." This is incorrect on two counts.

First, the animal models are supposed to progress through various species, until they arrive at animals that most closely resemble humans; chimps. The animal models being cited are mice or hamsters, which are very, very low on the totem pole.

Second, what are these mice being injected with? It's supposed to be pure virus. But instead, it's a soup which contains all sorts of material, including chemicals. The chemicals could be causing the animals to become ill.

Here is my breaking story about the virus that isn't there, from yesterday:

The CDC document is titled, <u>"CDC 2019-Novel Coronavirus (2019-nCoV) Real-Time RT-PCR Diagnostic Panel."</u> It is dated July 13, 2020.

Buried deep in the document, on page 39, in a section titled, "Performance Characteristics," we have this: "Since no quantified virus isolates of the 2019-nCoV are currently available, assays [diagnostic tests] designed for detection of the 2019-nCoV RNA were tested with characterized stocks of in vitro transcribed full length RNA..."

The key phrase there is: "Since no quantified virus isolates of the 2019-nCoV are currently available..."

Every object that exists can be quantified, which is to say, measured. The use of the term "quantified" in that phrase means: the CDC has no measurable amount of the

virus, because it is unavailable. THE CDC HAS NO VIRUS.

A further tip-off is the use of the word 'isolates." This means NO ISOLATED VIRUS IS AVAILABLE.

Another way to put it: NO ONE HAS AN ISOLATED SPECIMEN OF THE COVID-19 VIRUS.

NO ONE HAS ISOLATED THE COVID-19 VIRUS.

THEREFORE, NO ONE HAS PROVED THAT IT EXISTS.

As if this were not enough of a revelation to shock the world, the CDC goes on to say they are presenting a diagnostic PCR test to detect the virus-that-hasn't-been-isolated... and the test is looking for RNA which is PRESUMED to come from the virus that hasn't been proved to exist.

THE FALSE CLAIMS ACT

Many of the Fraud Section's cases are suits filed under the False Claims Act (FCA), 31 U.S.C. §§ 3729 – 3733, a federal statute originally enacted in 1863 in response to defense contractor fraud during the American Civil War.

The FCA provided that any person who knowingly submitted false claims to the government was liable for double the government's damages plus a penalty of \$2,000 for each false claim. The FCA has been amended

several times and now provides that violators are liable for treble damages plus a penalty that is linked to inflation.

In addition to allowing the United States to pursue perpetrators of fraud on its own, the FCA allows private citizens to file suits on behalf of the government (called "qui tam" suits) against those who have defrauded the government. Private citizens who successfully bring qui tam actions may receive a portion of the government's recovery. Many Fraud Section investigations and lawsuits arise from such qui tam actions.

The Department of Justice obtained more than \$3 billion in settlements and judgments from civil cases involving fraud and false claims against the government in the fiscal year ending Sept. 30, 2019. More information about those recoveries can be found here and the 2018 FCA statistics can be found here.

The Elements of Fraud

For an allegation of criminal fraud to be proven at law, the following elements must be in place:

- 1. Party A knowingly relies upon dishonest statements for the purposes of procuring material gain.
- 2. Party B is caused to rely upon those dishonest statements by the actions of Party A.
- 3. Party B [and Party C, D, E etc, whenever appropriate] suffers losses [or might have suffered them] as a direct result of relying on the dishonest statements of Party A.
- 4. Party A becomes guilty of committing fraud the moment they obtain material gain from relying upon their dishonest statements, whether Parties B and C suffered losses or not.
- 18 U.S. Code §1040. Fraud in connection with major disaster or emergency benefits:
- (a) Whoever, in a circumstance described in subsection (b) of this section, knowingly—
- (1) falsifies, conceals, or covers up by any trick, scheme, or device any material fact; or

- (2) makes any materially false, fictitious, or fraudulent statement or representation, or makes or uses any false writing or document knowing the same to contain any materially false, fictitious, or fraudulent statement or representation, in any matter involving any benefit authorized, transported, transmitted, transferred, disbursed, or paid in connection with a major disaster or emergency declaration under section 401 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5170) or an emergency declaration under section 501 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5191), or in connection with any procurement of property or services related to any emergency or major disaster declaration as a prime contractor with the United States or as a subcontractor or supplier on a contract in which there is a prime contract with the United States, shall be fined under this title, imprisoned not more than 30 years, or both.
- (b) A circumstance described in this subsection is any instance where—
- (1) the authorization, transportation, transmission, transfer, disbursement, or payment of the benefit is in or affects interstate or foreign commerce;
- (2) the benefit is transported in the mail at any point in the authorization, transportation, transmission, transfer, disbursement, or payment of that benefit; or
- (3) the benefit is a record, voucher, payment, money, or thing of value of the United States, or of any department or agency thereof.
- (c) In this section, the term "benefit" means any record, voucher, payment, money or thing of value, good, service, right, or privilege provided by the United States, a State or local government, or other entity.

ATOMIC BOMBSHELL: No proof for the RNA being of viral origin

Now the question is: What is required first for virus isolation/proof? We need to know where the RNA for which the PCR tests are calibrated

comes from.

As textbooks (e.g., White/Fenner. Medical Virology, 1986, p. 9) as well as leading virus researchers such as Luc Montagnier or Dominic Dwyer state, particle purification — i.e. the separation of an object from everything else that is not that object, as for instance Nobel laureate Marie Curie purified 100 mg of radium chloride in 1898 by extracting it from tons of pitchblende — is an essential pre-requisite for proving the existence of a virus, and thus to prove that the RNA from the particle in question comes from a new virus.

The reason for this is that PCR is extremely sensitive, which means it can detect even the smallest pieces of DNA or RNA — but it cannot determine where these particles came from. That has to be determined beforehand.

Because the PCR tests are calibrated for gene sequences (in this case RNA sequences because SARS-CoV-2 is believed to be a RNA virus), we have to know that these gene snippets are part of the looked-for virus. And to know that, correct isolation and purification of the presumed virus has to be executed.

Hence, we have asked the science teams of the relevant papers which are referred to in the context of SARS-CoV-2 for proof whether the electron-microscopic shots depicted in their in vitro experiments show purified viruses.

But not a single team could answer that question with "yes" — and nobody said purification was not a necessary step. We only got answers like "No, we did not obtain an electron micrograph showing the degree of purification."

We then trypsinized and resuspended Vero cells in DMEM containing 10% fetal bovine serum, 2× penicillin/streptomycin, 2× antibiotics/antimycotics, and 2× amphotericin B at a concentration of 2.5 × 105 cells/mL. We added 100 μL of cell suspension directly to the

clinical specimen dilutions and mixed gently by pipetting. We then grew the inoculated cultures in a humidified 37°C incubator in an atmosphere of 5% CO2 and observed for cytopathic effects (CPEs) daily. We used standard plaque assays for SARS-CoV-2, which were based on SARS-CoV and Middle East respiratory syndrome coronavirus (MERS-CoV) protocols (9,10).

When CPEs were observed, we scraped cell monolayers with the back of a pipette tip. We used 50 μL of viral lysate for total nucleic acid extraction for confirmatory testing and sequencing. We also used 50 μL of virus lysate to inoculate a well of a 90% confluent 24-well plate."

Health Canada has no record of "COVID-19 virus" isolation

A colleague in New Zealand and I (CM) have been submitting Freedom of Information requests to various institutions around the world seeking records that describe the isolation of a SARS-COV-2 virus from any unadulterated sample taken from a diseased patient. Our requests have not been limited to records of isolation performed by the respective institution, or limited to records authored by the respective institution, rather they were open to any records describing "COVID-19 virus" isolation performed by anyone, ever, anywhere on the planet.

Thus far (September 4, 2020) 8 Canadian institutions have provided their final responses: Health Canada, the National Research Council of Canada, Vaccine and Infectious Disease Organization-International Vaccine Centre (VIDO-InterVac), the Region of Peel (Ontario), the University of Toronto, Sunnybrook Health Sciences Centre, McMaster University and Mount Sinai Hospital (Toronto) (researchers from the last 4 institutions had publicly claimed to have "isolated the virus").

Every institution has indicated the same: that they searched their records and located none describing the isolation of any "COVID-19 virus" directly from a patient sample that was not first unadulterated with other sources of genetic material. (Those other sources are typically monkey kidney aka "Vero" cells and fetal bovine serum). (Update, October 9 2020: One institution has now failed to co-operate. Shame on you, University of Auckland. More on that further below.)
