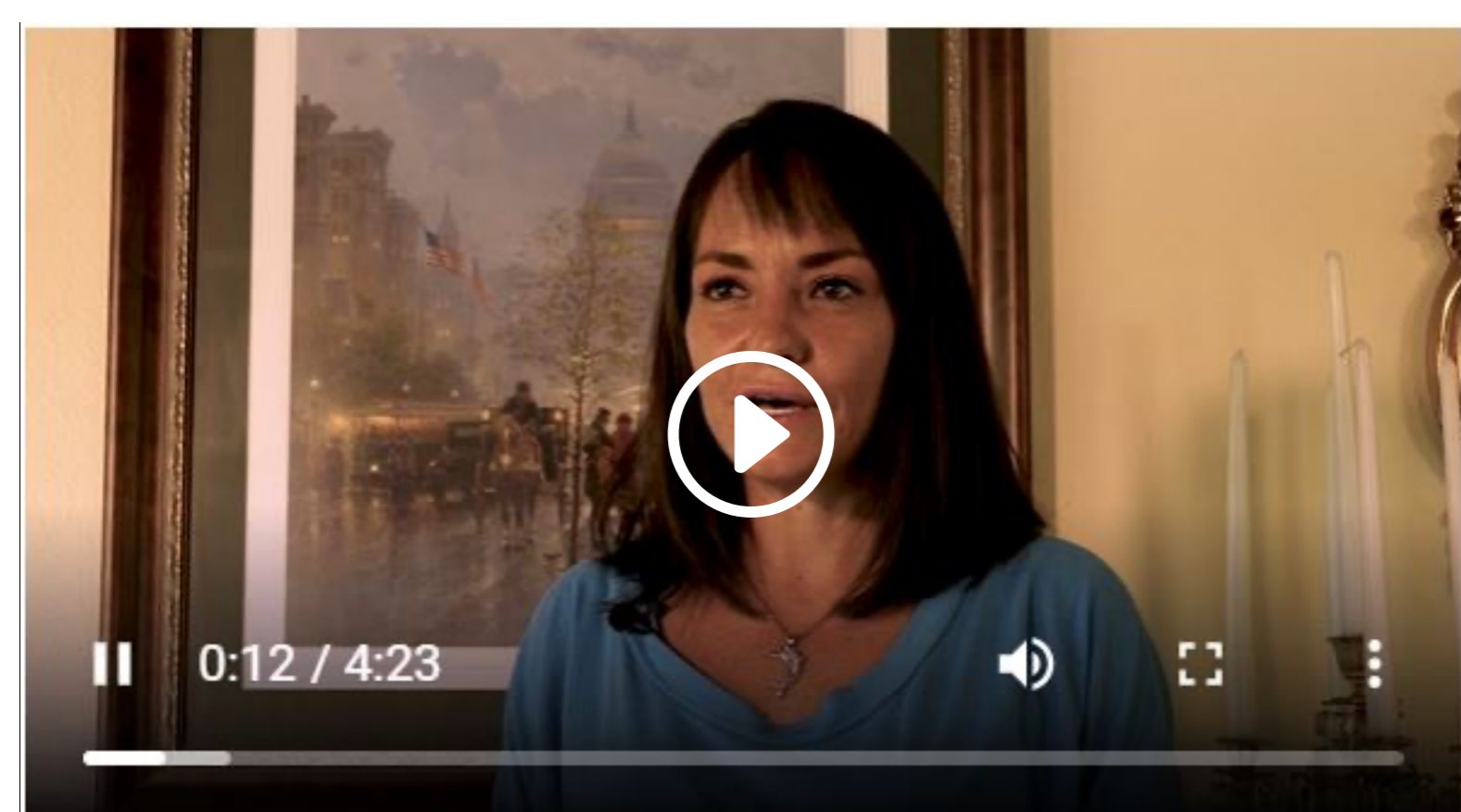


# TOGETHER WE CAN RESTORE OUR FREEDOM
