Through favorable court rulings and illegal executions, the bankers evicted 9.3 million families. More than 20 million people lost their property, often due to illegal or fraudulent debt. A small number of financial fraudsters, including executives from major Wall Street banks (Goldman Sachs, JP Morgan, etc.), paid fines, but no one went to prison for the gigantic fraud that put millions of Americans in misery.
